I am pleased to write on behalf of The Tiny Miracles Foundation, Inc., to request your support to help local premature babies and their families by donating a live or silent auction item to our May 5th Gala, *A Night of Sparkling Miracles* to be held at the Wee Burn Beach Club in Rowayton, CT.

The Tiny Miracles Foundation is a non-profit organization dedicated to providing vital support and assistance to families with premature babies in the greater Fairfield County area, and to helping the medical community provide the best possible care for premature babies and their families. Founded by two local mothers of severely premature twins in 2004, TTMF is now in its seventh year of providing critical support to families facing the crisis of premature birth through programs and services at Bridgeport, Norwalk and Stamford Hospitals, as well as to the preemie community at large. In March, they will expand their services to Danbury Hospital. Helping over 1,200 local families per year, and countless others who use their website, TTMF remains the only organization to provide comprehensive support for families of premature infants in the region. Our in-hospital programs include parent mentoring, family Resource Rooms, welcome and home care supplies, emergency financial assistance and equipment for needy families, and grants to hospitals for life-saving equipment and training. TTMF also sponsors a parent support network, a comprehensive website and professional resource referrals outside of the hospitals. All programs and materials are offered in English and Spanish and are free-of-charge to the families we help.

This is the seventh annual gala event to raise funds for the support of our programs, and this year to raise funds for our expansion to Danbury Hospital. The theme for the evening will be A Night of Sparkling Miracles. The event includes a silent and live auction, cocktails, dinner and dancing. This event has sold out every year to 300 attendees from throughout Fairfield County. It is our hope that you will consider making a tax-deductible in kind donation to the gala this year.
